

RESOLUTION 1998-2

**A RESOLUTION CANCELING THE MUNICIPAL ELECTION SCHEDULED FOR
APRIL 7, 1998 AND DECLARING CERTAIN CANDIDATES ELECTED:**

WHEREAS, there is now tentatively scheduled a municipal election to be held by the Town of Crestone on April 7, 1998 for the purpose of electing three persons to the office of member of the Board of Trustees of the Town of Crestone to fill vacancies with respect thereto arising from the expiration of the term of three present office holders,

AND WHEREAS, only three candidates, namely Charles Ehardt, M. Catherine Snider and Dan Gray, have filed nomination petitions, all such documents having been filed in the form and manner and within the periods of time required by law and by the Town of Crestone Ordinance 1992-1,

AND WHEREAS, said Ordinance 1992-1, adopted by the Town of Crestone pursuant to Colorado Revised Statute 31-10-507: provide that, if the only matter before the voters is the election of persons to office and if, at the close of business on the nineteenth day before the election, there are not more candidates than offices to be filled at such an election, including candidates filing affidavits of intent, the Clerk shall certify such fact to the governing body, and it shall hold a meeting and may cancel the election and by resolution declare the candidates elected,

AND WHEREAS, at the close of business on nineteenth day preceding the election, such day being March 20, 1998, the only matter before the voters is the election of persons to office and there were not more candidates than offices to be filled at such election,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF CRESTONE AS FOLLOWS:

1. The Board of Trustees finds that the only matter before the voters with respect to the municipal election tentatively scheduled for April 7, 1998 is the election of persons to office and that on the close of business on March 20, 1998, there were not more candidates than offices to be filled at such election, including candidates filing affidavits of intent.
2. That the Board of Trustees find that there are now three vacancies on the Board of Trustees of the Town of Crestone arising from termination of the term of offices of three persons presently holding such offices.

3. That the Board of Trustees find that there are now three candidates, namely Charles Ehardt, M. Catherine Snider and Dan Gray, such being the number of offices to be filled at such election.

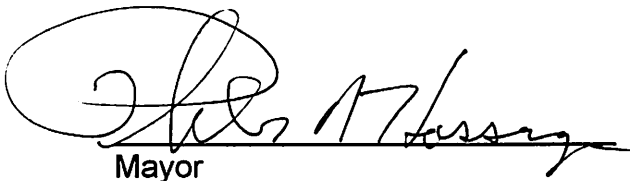
BE IT FURTHER RESOLVED:

1. That pursuant to the terms and provision of said Ordinance 1992-1, the above named three candidates, namely Charles Ehardt, M. Catherine Snider and Dan Gray be, and they are hereby declared to be, duly qualified to assume the duties of the office of members of the Board of Trustees in the Town of Crestone and are hereby deemed to be duly elected for a four-year term.

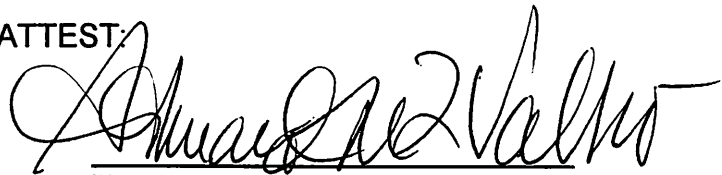
2. That notice of such cancellation shall be published, in order to inform the electors of the municipality, and notice of such cancellation shall be posted at each polling place and in not less than one other location.
