

RESOLUTION 316 2016

A RESOLUTION AMENDING THE FEE SCHEDULE
OF THE TOWN OF CRESTONE, COLORADO
ADOPTED BY ORDINANCE 2006-009

WHEREAS, the Board of Trustees of the Town of Crestone established a comprehensive Fee Schedule on April 10, 2006, by the provisions of Ordinance 2006-009; and

WHEREAS, said Ordinance provides that said schedule may be amended or modified from time to time by Resolution of the Town board of Trustees; and

WHEREAS, the Board of Trustees desires to amend the town's fee schedule relating to modification of liquor licensed premises and to impose fees relating to marijuana store applications, permits, annual renewal and changes in trade names for retail marijuana stores.

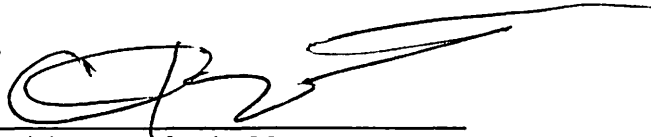
